SUMMARY

- The final Offer Price has been fixed at HK\$12.66 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.005%, investor compensation levy of 0.002% and Stock Exchange trading fee of 0.005% payable thereon).
- A total of 7,425 valid applications pursuant to the Public Offer on **white, yellow** and **pink** Application Forms and through giving **electronic application instructions** to HKSCC for a total of 68,643,600 Public Offer Shares were received, representing approximately 3.77 times the total number of 18,200,000 Public Offer Shares initially available for subscription under the Public Offer. Among the applications under the Public Offer, a total of 262 valid applications pursuant to the Public Offer on **pink** Application Forms for 983,600 Public Offer Shares were received, equivalent to approximately 54.04% of the maximum number of 1,820,000 Public Offer Shares available for subscription by eligible employees of the Group in Hong Kong on a preferential basis.
- Since the subscription in the Public Offer did not exceed 273,000,000 Public Offer Shares (and was accordingly less than 15 times the number of Public Offer Shares initially available for subscription under the Public Offer), the clawback mechanism was not triggered.
- The 136,500,000 International Placing Shares (subject to the Over-allotment Option) initially available to professional, institutional and individual investors under the International Placing for subscription by the Company, and sale by DSFH, were slightly over-subscribed.
- A total of 203 valid applications pursuant to the Preferential Offer on **blue** Application Forms for a total of 15,324,631 Reserved Shares were received, representing approximately 0.56 times the total number of 27,300,000 Reserved Shares initially available to Qualifying DSFH Shareholders for subscription under the Preferential Offer.
- Share certificates for wholly or partially successful applications on **white, pink** and **blue** Application Forms (which are either not available for personal collection or which are available for personal collection but are not collected in person) will be despatched by ordinary post to the addresses of the applicants specified in the relevant Application Forms at their own risk on Tuesday, 29 June 2004.
- Share certificates for the Public Offer Shares allocated to wholly or partially successful applications on **yellow** Application Forms and through giving **electronic application instructions** to HKSCC will be issued in the name of HKSCC Nominees and are expected to be deposited into CCASS for credit to their CCASS Investor Participant stock accounts or their designated CCASS Participants' stock accounts, as the case may be, at the close of business on Tuesday, 29 June 2004, or under contingent situations, on such other date as shall be determined by HKSCC or HKSCC Nominees.

DETERMINATION OF FINAL OFFER PRICE

The final Offer Price was agreed between the Company, DSFH and the Joint Bookrunners (on behalf of the Public Offer Underwriters) at HK\$12.66 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.005%, investor compensation levy of 0.002% and Stock Exchange trading fee of 0.005% payable thereon) on Thursday, 24 June 2004.

APPLICATIONS RECEIVED AND ALLOCATION OF OFFER SHARES

The Directors are pleased to announce that at the close of the application lists at 12:00 noon on Thursday, 24 June 2004, a total of 7,425 valid applications had been received pursuant to the Public Offer on **white**, **yellow** and **pink** Application Forms and through giving **electronic application instructions** to HKSCC for a total of 68,643,600 Public Offer Shares, representing approximately 3.77 times the total number of 18,200,000 Public Offer Shares initially available for subscription under the Public Offer.

Of the 7,163 valid applications for Public Offer Shares received on **white** and **yellow** Application Forms and through giving **electronic application instructions** to HKSCC (and excluding valid applications for Public Offer Shares on **pink** Application Forms), a total of 7,142 valid applications in respect of a total of 45,310,000 Public Offer Shares were for Shares with an aggregate subscription amount (excluding brokerage of 1%, SFC transaction levy of 0.005%, investor compensation of 0.002% levy and Stock Exchange trading fee of 0.005% payable on the initial Offer Price of HK\$13.86 per Share) of HK\$5 million or less in Pool A (representing approximately 5.53 times the 8,190,000 Public Offer Shares initially comprised in Pool A) and a total of 21 valid applications in respect of a total of 22,350,000 Public Offer Shares were for Shares with an aggregate subscription amount (excluding brokerage of 1%, SFC transaction levy of 0.005%, investor compensation levy of 0.002% and Stock Exchange trading fee of 0.005% payable on the initial Offer Price of HK\$13.86 per Share) of more than HK\$5 million in Pool B (representing approximately 2.73 times the 8,190,000 Public Offer Shares initially comprised in Pool B).

All multiple and suspected multiple applications in the Public Offer have been rejected.

No application for more than 50% of the Public Offer Shares initially offered for subscription under the Public Offer, after deducting the 1,820,000 Public Offer Shares available for subscription by eligible employees of the Group in Hong Kong (that is more than 8,190,000 Public Offer Shares), has been identified.

The Directors further announce that 262 valid applications for a total of 983,600 Public Offer Shares were received from eligible employees of the Group in Hong Kong on **pink** Application Forms, equivalent to approximately 54.04% of the maximum number of 1,820,000 Public Offer Shares available for subscription by eligible employees of the Group in Hong Kong on a preferential basis. The applicants under the **pink** form applications are independent of, and not connected with, any of the directors, the chief executive or the substantial shareholders of the Company or any of its subsidiaries, or associates of any of them.

The Public Offer Shares validly applied for on **white, yellow** and **pink** Application Forms and through giving **electronic application instructions** to HKSCC were conditionally allocated on the basis as set out in the paragraph headed “Basis of allocation” below.

Since the subscription in the Public Offer did not exceed 273,000,000 Public Offer Shares (and was accordingly less than 15 times the number of Public Offer Shares initially available for subscription under the Public Offer), the clawback mechanism was not triggered.

The Directors further announce that valid applications were received for more than the 136,500,000 International Placing Shares initially available to professional, institutional and other investors under the International Placing. The International Placing Shares were slightly over-subscribed. Of the 136,500,000 International Placing Shares, 54,600,000 Shares are new Shares allotted and issued by the Company and 81,900,000 Shares are Shares sold by DSFH. Subject to the satisfaction of the conditions set out in the paragraph headed “Conditions of the Public Offer” under the section headed “Structure and Conditions of the Global Offering” in the Prospectus, the total number of 136,500,000 International Placing Shares under the International Placing were conditionally allocated in full and 11,975,369 unsubscribed Reserved Shares were reallocated from the Preferential Offer to the International Placing. In addition, a further 17,874,231 Shares have been allocated under the International Placing, the settlement of which will be effected by the stock borrowing arrangement pursuant to the Stock Borrowing Agreement.

The Directors further announce that at the close of the application lists at 12:00 noon on Thursday, 24 June 2004, a total of 203 valid applications were received pursuant to the Preferential Offer on **blue** Application Forms for a total of 15,324,631 Reserved Shares, representing approximately 0.56 times the total number of 27,300,000 Reserved Shares initially available to Qualifying DSFH Shareholders for subscription under the Preferential Offer.

The Public Offer Shares and the Placing Shares were allocated to places who are independent of, and not connected with, any of the directors, the chief executive or the substantial shareholders of the Company or any of its subsidiaries, or any of their respective associates. The Placing is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the Sponsor, the Underwriters or their respective associates and connected clients (as defined in Appendix 6 to the Listing Rules) has subscribed for any Offer Shares for its own account under the Placing.

The Listing Committee resolved that the Company may proceed with the listing of its securities with a public float of 15% or greater on the basis that the expected market capitalisation of the Company at the time of the Listing would exceed HK\$10 billion as specified in the Listing Rules, and on the condition that the Company and its controlling shareholders take appropriate steps to increase the public float to 25% of the Company's total issued share capital within 18 months from the date of Listing. The Company will initially be listed with a 20% public float (assuming that the Over-allotment Option is not exercised) and its market capitalisation will at the time of Listing be in excess of HK\$10 billion. DSFH currently intends to increase the number of Shares in public hands to 25% or more of the issued share capital of the Company within 18 months from the date of Listing either by the sale or disposal by DSFH of additional Shares or by procuring, to the extent that it is able, the issue by the Company of new Shares, or otherwise in accordance with the Listing Rules. The Company will make further announcements in due course to inform Shareholders of the proposals and will comply fully with the Listing Rules.

The Company and DSFH have granted to the International Placing Underwriters the Over-allotment Option exercisable by the Global Co-ordinator on behalf of the International Placing Underwriters for up to 30 days after the date of the Prospectus, to require the Company to allot and issue, and DSFH to sell, up to an aggregate of 27,300,000 additional Shares. The Global Co-ordinator may exercise the Over-allotment Option or make purchases in the secondary market to cover over-allocations under the International Placing. If the Over-allotment Option is exercised, a press announcement will be made.
